Subject: Grievances against the Raiders United 2013 Campaign Team

We, the campaign team for Stovall, Weeks, Craig, & Yates, hereby file the following grievances against the Raiders United: Cotton, Dickensen, Berger campaign team. We ask the Election Commission to review these grievances and consult the official Election Code on the rules and guidelines for all elections.

Email Spam: We have in our possession (attached) two emails in which the Raiders United campaign team has sent to mass populations including the University Fountains apartment complex and the Goin' Band from Raiderland. Both emails explicitly ask the readers to vote for Raiders United coalition members and Jill Berger's email signature is clearly seen (along with her current position's title) on one of the emails. This is a violation according to the Election Code Sections 2.14 and 6.08:

"Spamming: refers to use of electronic messaging systems to send unsolicited bulk messages indiscriminately."

"In conjunction with the student code of conduct, spamming is not allowed under any circumstance."

Facebook Event Posting: Alpha Phi posted (attached) on the 2013 Chilifest page asking all members of the event to vote for Raiders United coalition members. Alphi Phi also posted on their public 'like' page and asked their followers to support Raiders United. This is a violation according to the Election Code Section 6.16 and Section 6.17:

"In regards to social networking websites: messages, wall posts, etc. may only be sent to those who have specifically "opted-in" to hear about your candidacy."

"'Opting-in' is defined within a social networking website as any type of communication that allows a potential voter to choose whether or not they would like to receive information concerning a candidacy or the election (i.e. a group invitation, friend request, etc.)."

Current SGA Position: Jill Berger went into great detail about her current role in SGA during her three minute introduction without any of the candidates knowing that this was allowed or acceptable. As already mentioned, Jill also used her current role in an email sent out to the

University Fountains apartment complex, making two violations of this rule. This is against the rules according to Section 6.12:

"Candidates are not allowed to use any current position within the Student Government Association to campaign for any election."

Incentives for voting: There are many "I Voted" Raiders United Stickers being circulated for individuals to wear. These images have been posted on social media and offered to students who had not voted, enticing them to vote. This is against the rules according to Section 7.18:

Under no circumstances shall any penalty, reward, or incentive be applied or offered in exchange for voting in general, or for a specific candidate(s).

The Stovall, Weeks, Craig, & Yates campaign team desires to run an honest, rule-abiding campaign and we expect the same from our competition. If you have any questions please contact Caroline Weir at 318-243-2312 or <u>caroline.weir@ttu.edu</u>.


