Specifically, the alleged violation(s) include code item(s) (as found in Section B, Misconduct):

02.c.03. Sexual Misconduct - Nonconsensual Sexual Intercourse Sexual penetration or intercourse, however slight and with any object, without consent. Penetration can be oral, anal, or vaginal.

Taking into consideration the available documentation, evidence, reports received from , your statement, and hearing your explanation, the University Discipline Committee made the following determination regarding your responsibility for violating the following Section B section(s):

02.c.03. Sexual Misconduct - Nonconsensual Sexual Intercourse -- Responsible

The following decision has been made in accordance with the Code of Student Conduct as notated in the 2014-2015 Student Handbook:

Suspension

You are suspended effective October 14, 2014 through August 1, 2015. During this time, you are not allowed on campus. If you need to be on campus during the business day for official University business, you must receive approval from this office in advance. In order to be eligible for readmission, you must be in compliance with all aspects of this letter.

With respect to the information listed above, the following additional sanctions/stipulations apply:

You must complete a sensitivity and sexual misconduct training session, coordinated through the Dean of Students Office. This must be completed in order to re-enroll once the suspension is lifted on August 1, 2015. Michael Henry is your point of contact to schedule and complete this requirement.

Failure to comply with the sanction(s), condition(s), and/or restriction(s) described herein may result in further judicial action such as an <u>Administrative Hold</u> being placed on your records until completion. Please note this may affect your ability to drop, add or register for classes, receive financial aid, or request transcripts.

Should you wish to appeal this administrative disciplinary hearing decision in accordance with Part X, Section E "Disciplinary Appeal Procedures," a formal *letter of appeal*, written or email, must be submitted to Dr. Amy Murphy, Dean of Students, on or before October 14, 2014.
